

Reunification promotion for 2025

Land Prime Ltd (hereinafter referred to as "Land Prime") is set to launch Reunification promotion for 2025 (hereinafter referred to as "Promotion"). All qualified clients (hereinafter referred to as "client") may have chance to participate in the Promotion.

Terms & Conditions:

- 1. This promotion is only available for Land Prime clients from Vietnam.
- Promotion period: 00:00 May 7th 2025 ~ 23:59 June 7th 2025 (Land Prime Server time, GMT).
- 3. Only clients with verified documents e.g. PLE/POA can participate in the promotion. Furthermore, the Company reserves the right to request additional documentation for identification if suspicious circumstances are detected.
- 4. This promotion is available exclusively for Standard accounts.
- The basic trading conditions to qualify for the promotion benefits are as follows:
 5.1 A deposit of at least \$300 is required.
 5.2 Clients must achieve the specified trading volume (15) standard lets, based on the specified trading volume (15).

5.2 Clients must achieve the specified trading volume (15) standard lots based on the promotion's terms.

5.3 If the client successfully traded (15) standard lots (excluding Index and Stocks), client would be eligible to receive \$200(=5,000,000 VND) as a balance (not a bonus).
5.4 The trading volume is calculated based solely on closed positions and must be

completed within the promotion period. Any trading volume generated outside of the specified period will be excluded.

5.5 All positions must remain open for a minimum of 3 minutes.

 - 9.3.2 Withhold, cancel and subtract from client's account(s) and/or from any other account(s) related to such client's account.
 - 9.3.3 Offset any resulting of profits/losses from related account(s).
 - 9.3.4 Terminate client's any services and contracts provided by Land Prime.
 - 9.3.5 Block client's account(s) by maintaining minimum regulatory requirements.
 - 9.3.6 Cancel profits, Introducing Broker (IB) commissions.
- 9.4 Land Prime reserves the right of final interpretation of this promotion.
- 9.5 Qualified client is the holder with a proof of address in Vietnam.
